L09/70 REPORTS FROM COMMITTEES, MEMBERS, AND STAFF REQUIRING BOARD ACTION

Request to Withdraw **Porn.o.logy** by Ayn Carrillo-Gailey

Ms. Hubbard Krimmer reported that the book <u>Porn.o.logy</u> by Ayn Carrillo-Gailey falls within the parameters of the existing LPL Collections Policy and due process had been followed in the re-consideration request.

A review of the Collections Policy is scheduled to be discussed in February, 2010 as part of a regular review process.

It was <u>MOVED</u> by Controller Barber and seconded by Councillor Branscombe that given the inclusion of the book, <u>Porn.o.logy</u> by Ayn Carrillo-Gailey is consistent with the LPL Collections Policy and the due process was followed, no further action be taken on this matter.

L09/70.1 Service Policy: Annual Review

The Library Board is undertaking its annual review of the LPL *Internet Service Policy*. The purpose of this report is to provide information to assist in that process and specifically to:

- Report on the implementation of the Internet Service Action Plan developed following adoption of the Internet Service Policy in November 2008;
- Provide a monitoring and review of the application of the Internet Service Policy;
- Identify supporting policies that address behavioural issues related to the public's use of Internet services; and
- Recommend any changes to the Internet Service Policy.

Board members discussed the imperfections of internet filtering, the fact that filtering by imagery is very challenging and hate sites as a filtering category.

Additional clarification regarding personal information per privacy legislation (MFIPPA) will be provided in item 1, paragraph 4, Internet Service Policy.

It was <u>MOVED</u> by Councillor Branscombe and seconded by Ms. Leckie that the London Public Library (LPL) Internet Service Policy, per Library Board motion L08/57 and as provided in Appendix 7 of this report, remain in effect as amended and that no changes be made at this time. It is also recommended that:

- Administration continue to monitor the progress of:
 - Ontario Provincial Parliament, Bill 202, Education Statute Law Amendment Act (Electronic Sexual Material), 2009;
 and

- House of Commons of Canada, Bill C-58, An Act respecting the mandatory reporting of Internet child pornography by persons who provide an Internet Service and Bill C-209, An act to prevent the use of the Internet to distribute pornographic material involving children:
- Administration update the Library Board on matters related to the policy, as required, and
- The Library Board conducts its annual review of the policy in November 2010 per the current policy.

This Confidentiality of Personal Information Policy must comply with the *Municipal Freedom of Information and Privacy Act*, RSO 1990, Chapter M.56, which protects the privacy of individuals with respect to personal information about themselves held by institutions and to provide individuals with a right of access to that information.

Following approval of the Confidentiality of Personal Information: Assumptions and Guiding Principles, staff will bring a recommended draft policy to the Board for approval at its January 2010 meeting.
